### SUBJECT: REORGANIZATION / SPECIAL RELIEF VACANCY AND RELIEF TRANSFER ORDERS

The Chicago Fire Department will be implementing administrative and geographical changes to EMS Districts, FS&R Districts and Battalions in the Bureau of Operations, effective July 16, 2015. The administrative changes, in conjunction with the addition of FS&R District Chiefs, will balance the span of control, as well as maintain the unity of command, for the department. Geographical changes will enhance service and emergency response capabilities by ensuring efficient utilization of the most proximate resources.

Please find the list of changes below.

- FS&R Districts will be realigned geographically and numerically to reflect Districts 1. through 5. An illustrated map can be viewed at: https://chicagogov.sharepoint.com/sites/fire/Maps/FSR%205-2015.pdf
- EMS Districts will be realigned geographically, and an illustrated map can be viewed at: https://chicagogov.sharepoint.com/sites/fire/Maps/EMS%205-2015.pdf
- The Office of Fire Investigation (OFI) headquarters and OFI Car 4-6-6 will be relocated from Engine 38's quarters to Engine 84.
- OFI Car 4-6-7 will be relocated from Engine 38's quarters to Engine 107.
- Battalion 4 will be relocated to from Engine 23's quarters to Engine 28.
- EMS Field Chief 4-5-7 will be relocated from Engine 18's quarters to Engine 23.

Battalions will be renumbered and reassigned companies, as indicated below:

#### SPECIAL RELIEF VACANCY AND TRANSFER ORDERS

As a result of the aforementioned changes and to ensure a balanced workforce, the department will be posting a Special Relief Vacancy Order. The provisions for implementing this Special Relief Vacancy Order have been agreed to with Local #2 and are as follows:

- All FS&R Relief Captains, Lieutenants and Engineers will be required to submit a Transfer Request.
- All FS&R Relief Captains, Lieutenants and Engineers who are <u>detailed</u> to a 40-hour position will be required to submit a Transfer Request.
- All Captains, Lieutenants and Engineers who have been permanently assigned to a 40-hour position for greater than a year will have the option to submit a Transfer Request
- All submitting members will be required to select Districts 1 through District 5 in order of preference.
- All submitting members will be required to select Platoon 1 through Platoon 3 in order of preference.
- New relief assignments will be awarded based on seniority.
- New platoon assignments will be awarded based on seniority.
- Any member who fails to submit a transfer request will be assigned a District and Platoon at the discretion of the department.
- All previously awarded furlough selections will be maintained.
- The effective date for the Special Relief Transfer will be July 16, 2015.
